

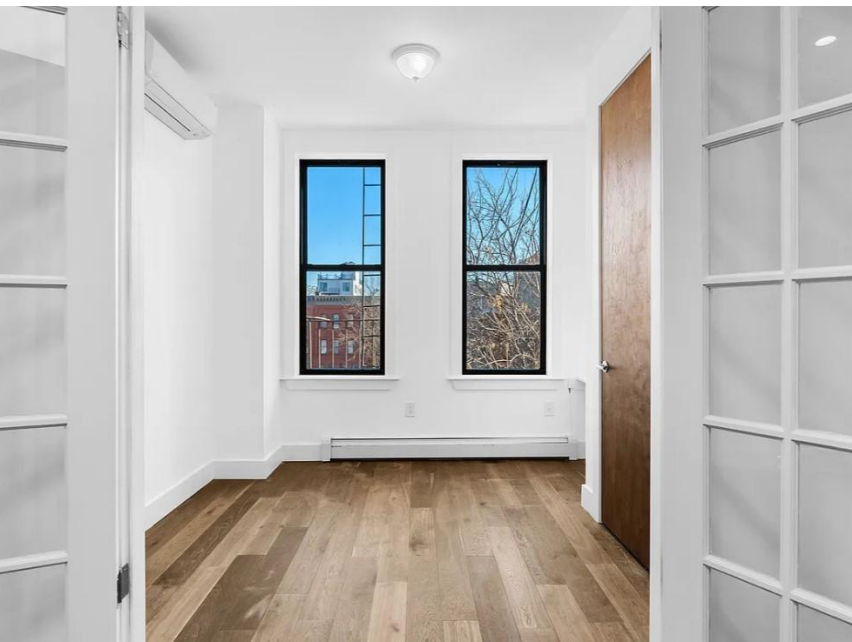

## Investment Highlights

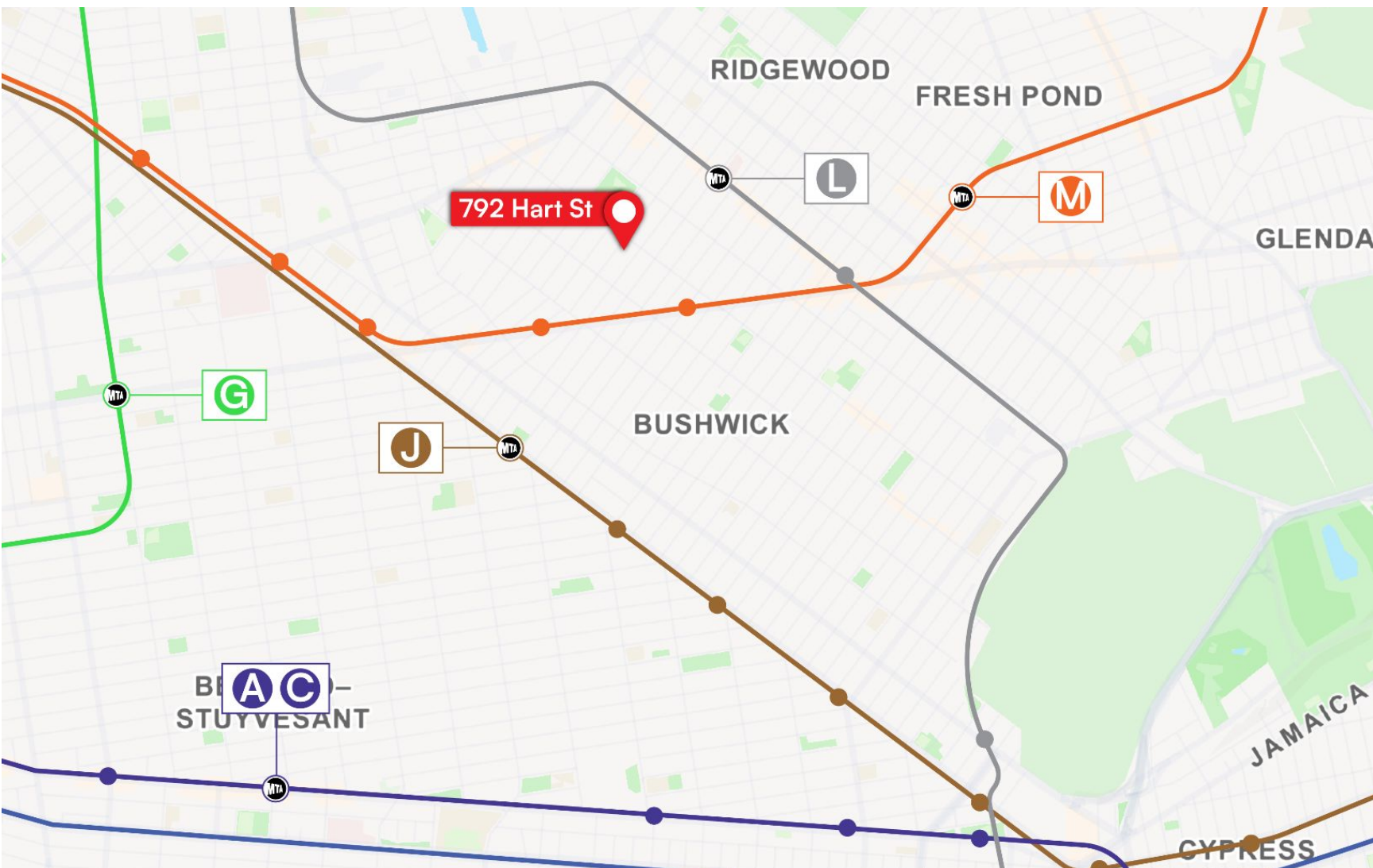

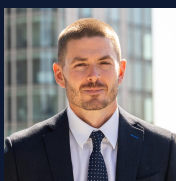
