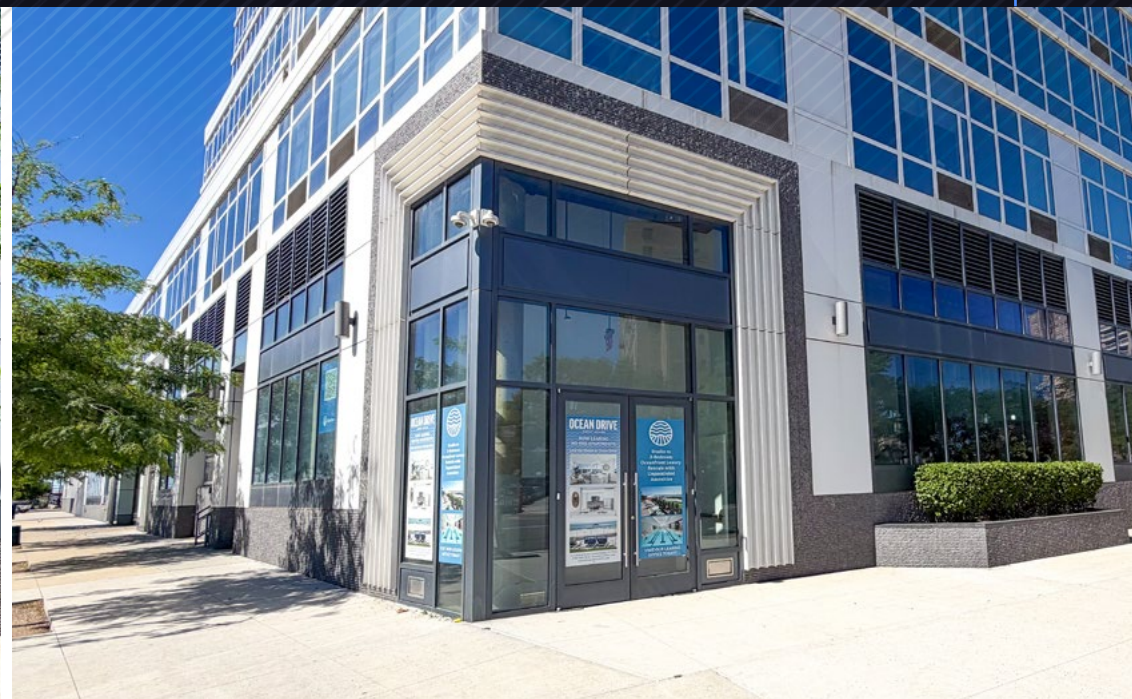

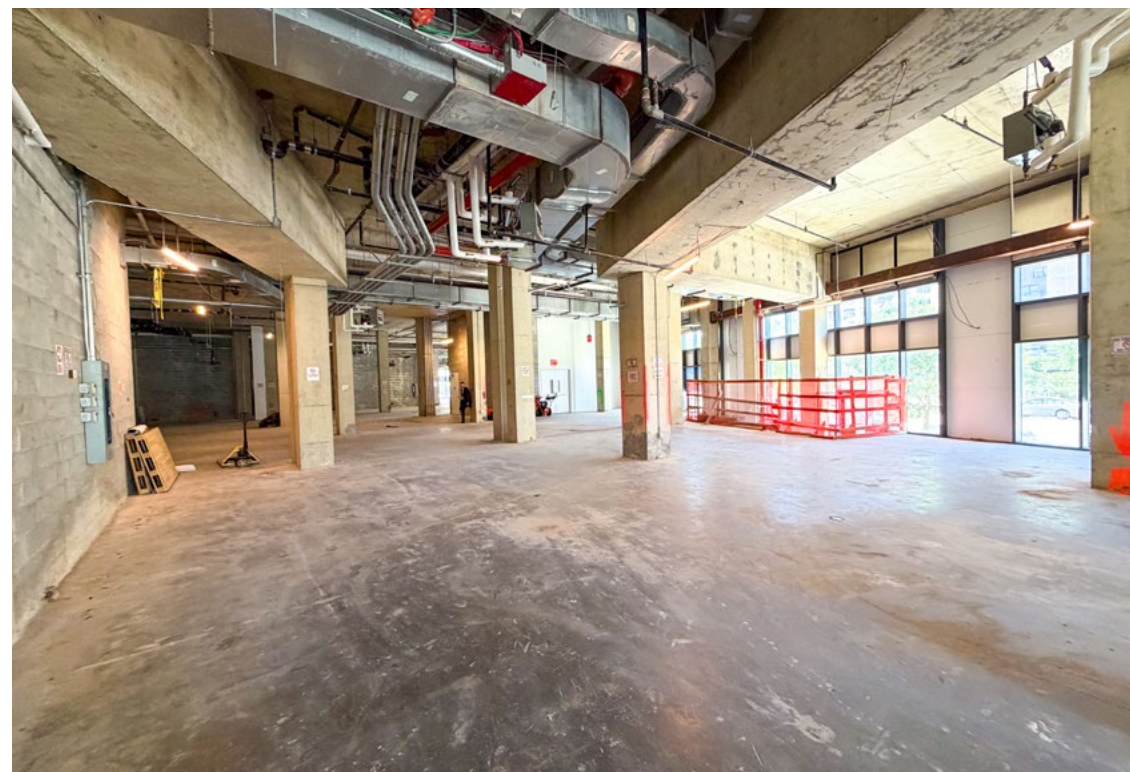

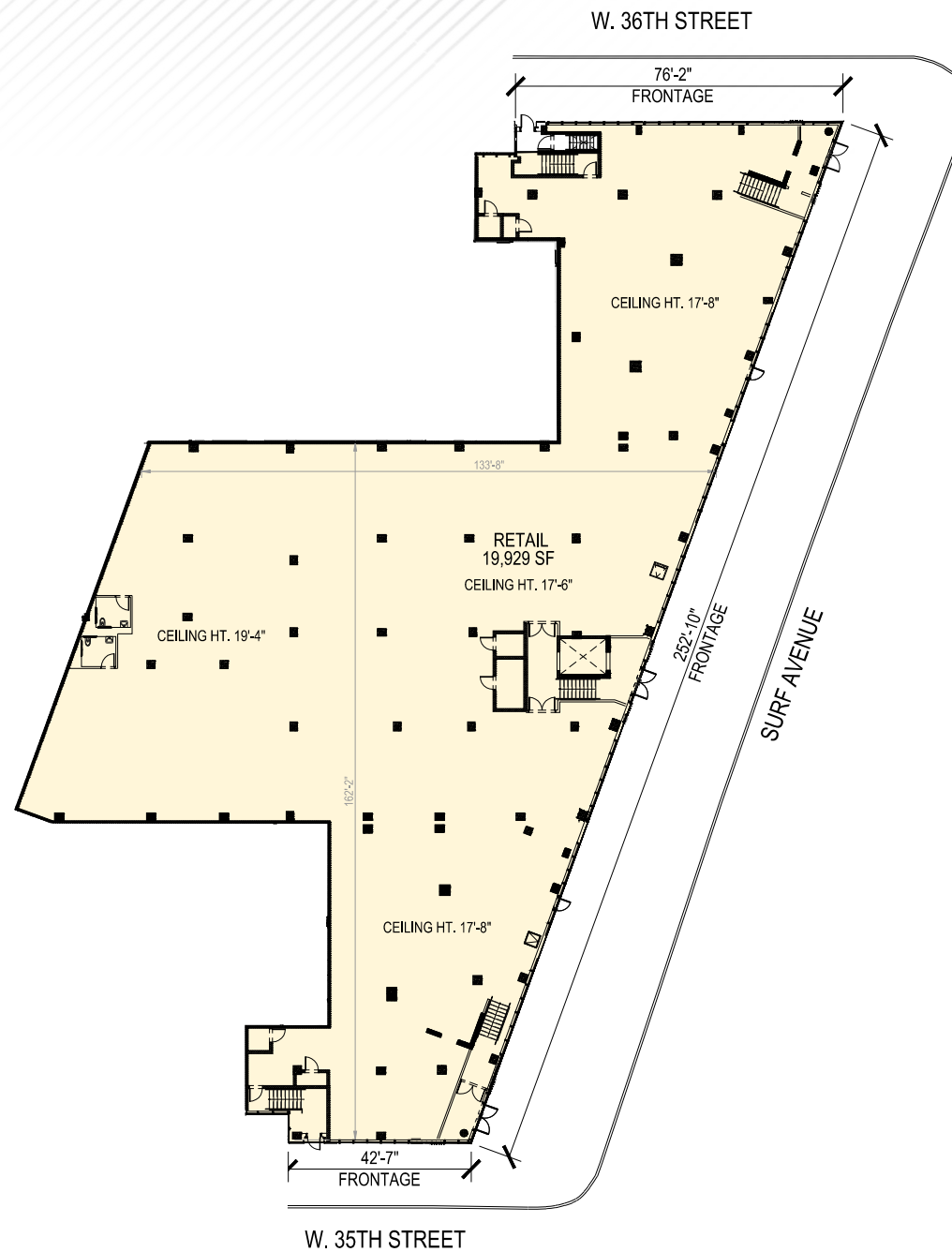

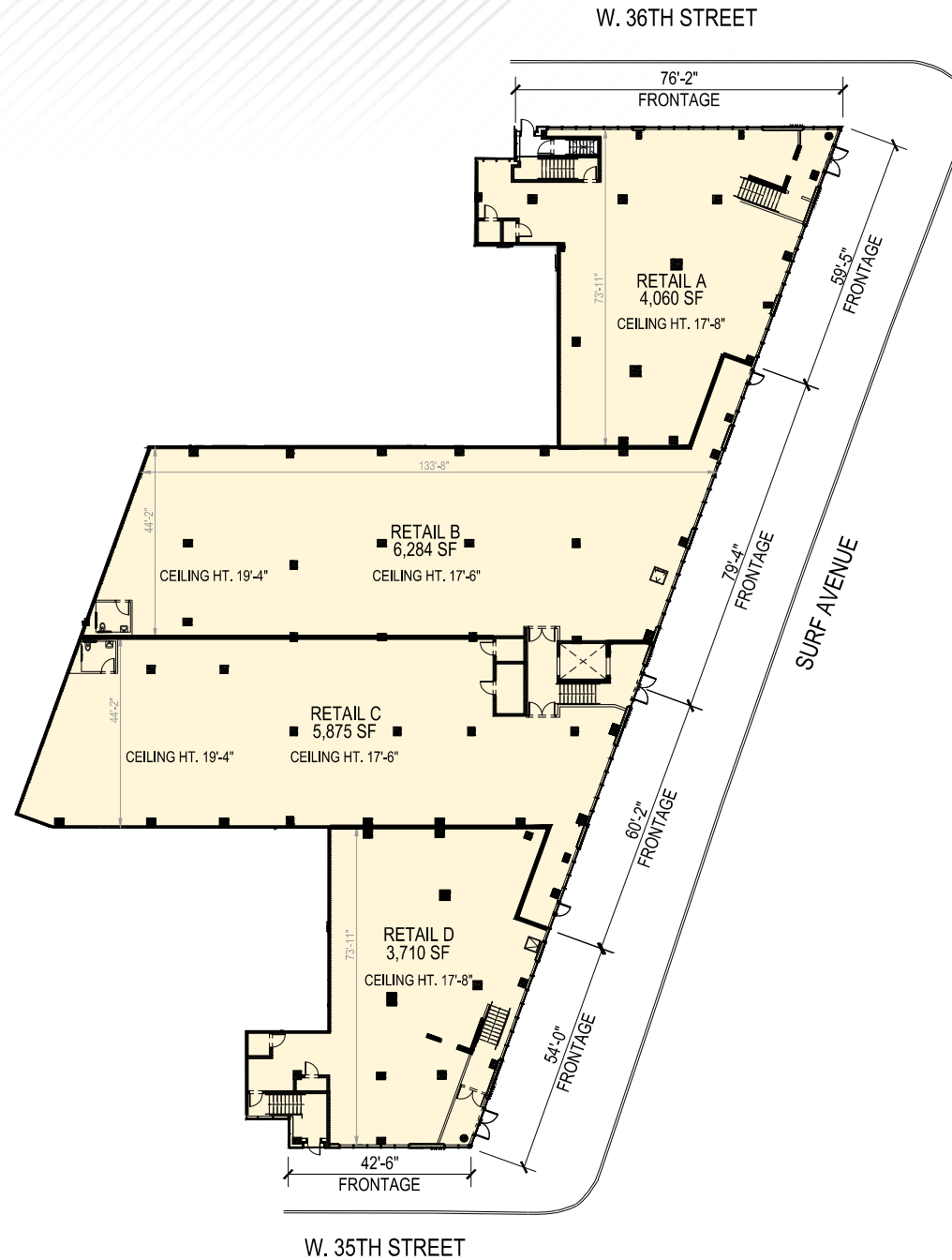


3514 SURF AVENUE FLOOR PLAN

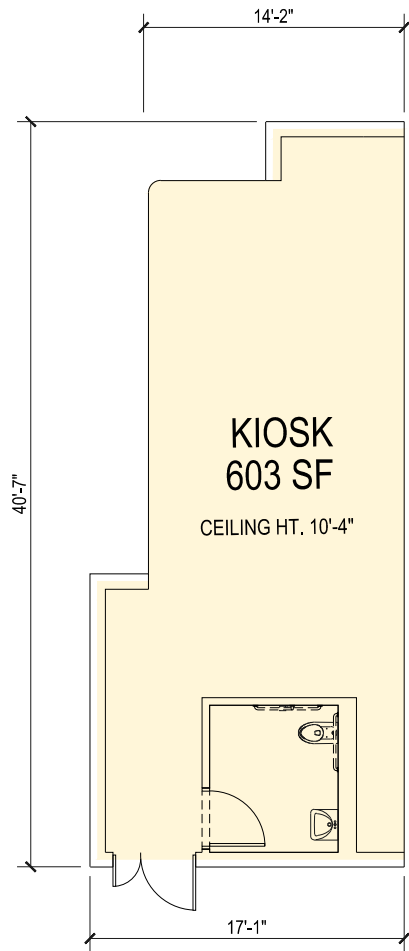


3514 SURF AVENUE FLOOR PLAN

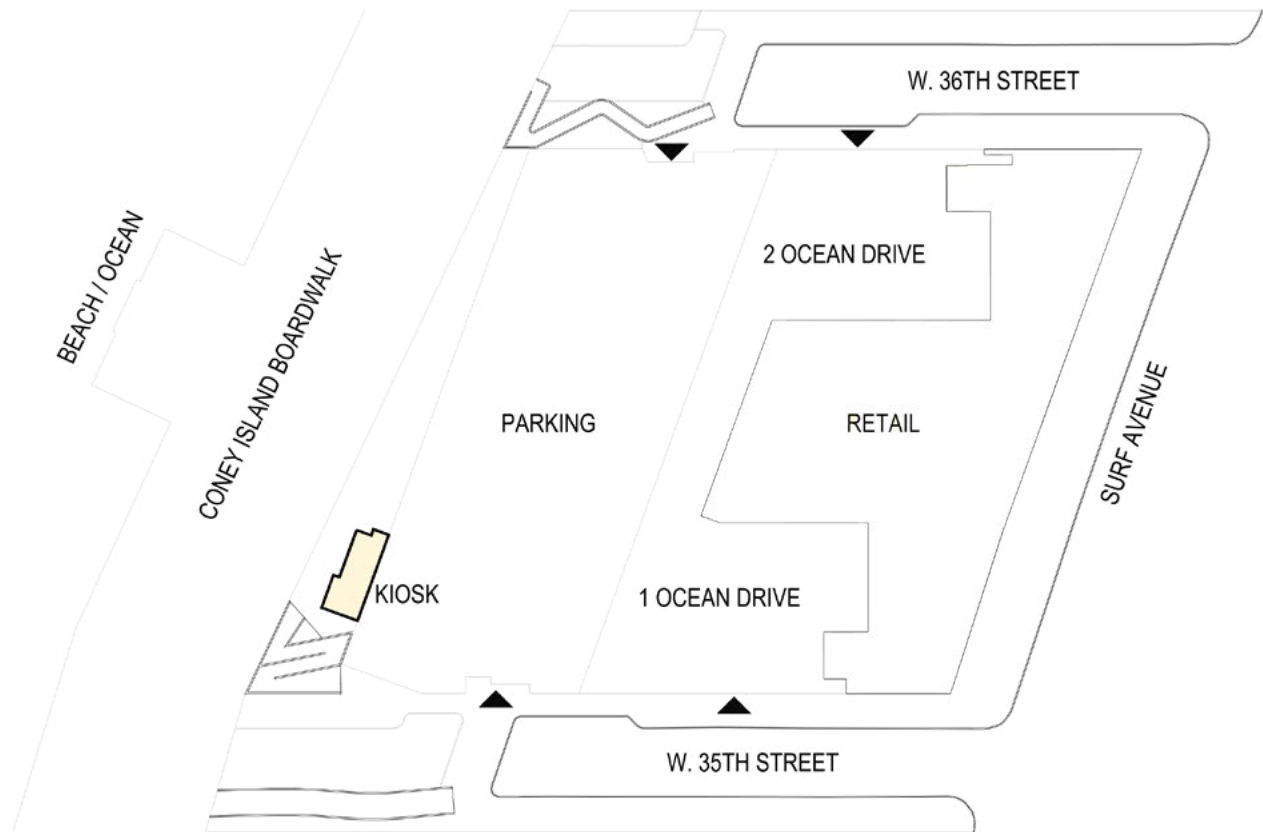


BOARDWALK KIOSK FLOOR PLAN
